6) Bluetooth connection

- 1. For the first time connecting, hold on the power button for 2s and headphone will enter pairing mode. The unit will remember the connected device and thus start auto-pairing in future after power on.
- 2. To pair a new device press and hold power button for 4s in state of shutdown to bring the earphone into pairing mode.
- 3. Connect to bluetooth device



To restore factory settings, press the power button for 6s in state of shutdown.
